



## ARTICLES OF INCORPORATION

TO THE DEPARTMENT OF STATE;  
COMMONWEALTH OF PENNSYLVANIA:

In compliance with the requirements of the "BUSINESS CORPORATION LAW," approved the 5th day of May, A. D. 1933, P. L. 364, as amended, the undersigned **all** of whom are citizens of the United States, desiring that they may be incorporated as a business corporation, do hereby certify:

1st. The name of the corporation is **MORRIS PAPER COMPANY**

2nd. The location and post office address of its initial registered office in this Commonwealth is

**Arsenal Terminal, Fortieth and Butler Streets, Pittsburgh, Allegheny**

3rd. The purpose or purposes of the corporation are:

**Manufacturing, buying, selling and dealing in paper,  
paper products, twines, packaging materials, hardware and  
similar merchandise.**

4th. The term of its existence is **perpetual**.

5th. The authorized capital stock of the corporation is **\$750,000.00** divided into\*

**7,500 shares of the par value of \$100.00 per share,**

**all of which is Common Stock.**

6th. The amount of paid in capital with which the corporation will begin business is

**Fifty Thousand Dollars (\$50,000.00)**
