Pews in Synagogue

THIS INDENTURE made the Tenth day of November 1902, between CONGREGATION TIFERETH ISRAEL of New Castle, Pa., a corporation created under the laws of the State of Pennsylvania, party of the first part, and ISAAC GROSSMAN of the City of New Castle, Lawrence County, Pa., party of the second part, WITNESSETH:-

That the said party of the first part in consideration of the sum of Seventy-Five Dollars, to it in hand paid by the said Isaac Grossman at and before the ensealing and delivery hereof, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, released and confirmed, and by these presents does grant, bargain, sell, assign, release and confirm unto the said Isaac Grossman, his heirs and assigns, the full, free and absolute right of occupancy use and possession of the following pews in the present Synagogue of said Congregation Tifereth Israel, at No. 1 Home Street, in the City of New Castle, Pa., and any other synagogue it may hereafter erect:- PEW No. 5 on the ground floor, and PEW No. 5 in the gallery. Together with all the rights and incidents necessary thereto.

TO HAVE AND TO HOLD the same to him the said Isaac Grossman, his heirs and assigns to his and their use and benefit, advantage and behoof forever. PROVIDED, that the right and advantage hereby granted shall be at all times held and enjoyed under and subject to the provisions of the charter of incorporation of the said Congregation Tifereth Israel, and of the By-Laws, rules and regulations thereof, lawfully enacted and created, and the said right and privilege shall not be sold, conveyed or transferred by the grantee herein or his heirs or assigns, except in con-

Received the day and date of the above written Indenture of the above named Isaac Grossman, the sum of Seventy-Five Dollars, being the full consideration above mentioned.
