

by and between THE DONORA HEBREW CONGREGATION OHAB
SHOLAM of the town of Donora, a corporation created and existing under the laws of the Common-
wealth of Pennsylvania, party of the first part,
AND adolf Moskowitz led Mrs adolf Moskowit

Miturasseth: That the party of the first part for and in consideration of the sum of \$. 100
Ourhundred Jole
lawful money of the United States of America, paid to the said party of the first part by the party of the second part, at or before
the delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained and sold and by these
presents does grant, bargain and sell, as well as release and confirm unto the said party of the second part, his heirs, executors
administrators or assigns, the use, occupancy and privilege of seat numberin the synagogue and the correspond
ing seat in the gallery, said seat beingseat in the even numbers of the right side and starting from the altar o
the building owned by said congregation, which is dedicated to the worship of the Almighty God and which is situated at the
southeast corner of Second Street and Thompson Avenue, in the Town of Donora, Pennsylvania, or wherever they may be here
after located, buy or build a new synagogue, so long as the party of the second part does abide by the Orthodox Hebrev
Religion; or may sell or rent said seat to any one of the same race, rite or religion, according to the restrictions below.
The party of the second part agrees to pay to the party of the first part an annual tax of \$2.00 on each and every sea
owned by him, with the exception of mizrach seats, for which an annual tax of \$4.00 must be paid, providing he is a member in
good standing of said congregation, which amount however, he is permitted to spend at the religious services for the benefit of
the congregation. If not a member of the said congregation, his annual tax shall amount to a sum equal to the yearly dues in
the said congregation.
The party of the second part agrees to pay the annual tax, donations and all other charges against him in the said congre
gation, not later than three days before every Hebrew New Years Day, and in case of failure to comply with such payment, part
of the second part hereby authorizes party of the first part and its officers to rent said seat at the best possible terms and collections.
the rent, until the full amount due is paid.
In case of a transfer or renting of said seat, the party of the second part agrees to notify the said congregation in writin
and to pay the sum of \$1.00 for such transfer, the purchaser or renter being bound by the same conditions enjoined upon the
party of the second part.
Before transferring any seat, the party of the first part has the privilege of re-purchasing same at the price offered.
