

of Trustees of three or more persons chosen from its member in such manner, time and place as shall be specified in its by laws, or the discipline of the Hebrew Church.

Seventh:- The officers of said Board of Trustees shall consist of a President, Vice President, Secretary and Treasurer to be chosen annually from among the members of the Board who shall perform all the duties usually assigned to such officers, and the following named persons shall constitute the Board of Trustees for the first year and until their successors are elected, namely:

Eighth:- The clear yearly value or income of any real estate which may be held by this corporation shall not exceed twenty thousand dollars exclusive of voluntary contributions. And this corporation embodies as a part of these its articles of incorporation the seventh section of the Act of April 26th 1855 so that all property, real or personal, belonging to said corporation, or which shall hereafter be bequeathed, devised or conveyed to it, shall not be otherwise taken, held, or to come, than subject to the control and disposition of the lay members of such church, congregation or religious society, or such constituted officers or representatives thereof as shall be composed of the majority of the lay members, citizens of Pennsylvania having a controlling power, according to the rules, regulations or usage or corporate requirements thereof, so far as consistent herewith.

Ninth:- This society assumes to itself, all the rights, power, privileges and immunities which are now and which may during the existence thereof be conferred by law upon societies of similar character, and adopts as its by laws the discipline of the Hebrew Church.
