A mooting of tho comnittoe for a Unitod Jewish Comunity In Boaver Valley was hold in tho Council House in Boaver Falis. The chairman pro tom, 112. Jacois Vonger, askod for nominations from tho floor for a tomporary ohaiman. Dr. M. F. Pottior noninated Jecob Venger. The nonination was seconded by 12re. Haxry Gonolin, and approvod by all prosent. The chaiman succested that a nominating comittee bo fomod to prosent a slato of pomanont offleers. Mr. Loonard Bortz mola tho point that such an organization as this one boing formed would be not only for the proose of builalng a comuntty builatine but also for the purpose of fomine a unified comunity. Mre. Haxry Greonblatt asked for a conclso 11 st of coals tovards whoh such a eroup would ain. . Pottior pointed out that. the appointed ropresontatives at this meetine havo not boon omporerod by their separate groups to make decisions but only to report back to thoir groups what has taken place.

1nr. Norton Canelin moved that the followinc coal bo adoptod: This eroup is mooting for the purpose of forming an orcanization to unify the Jewish cormunity and to build a jowish cozter with the holp of all the exioting local arganizations. This motion was soconded by 1rrs. Ph1111p Gorgon. A discussion followed on hov far this present group should procoed. A vote vas taken on this motion and it was so ordered. 14r. Milton Farizas pointed out that it misht bo bottor if this group functions as a soparate group and go to the other organiztions for help when a plan has boen formulated. By cenoral opinion it was docided that the vote of those present be individual votes and not be ropresenting any particular organization.

It was sugcested by 1 mms . Leonard schvartz that the appointed ropresentatives make up the nominating conmitteo. $1 n \mathrm{C}$.
T. A. Tenor sucgested that the permanot officers be members at large so that the appointod representetives would not be divided by dual Loyeltios: This susgostion was ovomuled. By genoral consoesus $1 t$ was agrood that tho nominatine commttoo should moot in seperate seosion. Mr. Momen Soodtr movod that the appointed representatives malso up the nominating comittoo In addition to 3 persons at inree. This motion ves soconded by Mr. Momels Tabovitz. A vote was talzo and the notion camided. with one apposing vote.

1r. T.A. Tenor polnted out that there should be a tomporary constitution so that it micht havo a mothod of operation. Mr. Bortz moved that tho chatman appoint a commttoo to fomulato a provisional chartor to bo prosontod at the noxt mooting. The nominating comittee vould thon moot aftor the ohartor comnlttee so that thoy would havo some 1 dee as to what offlcers woisld bo noodod. This motion was socondod by Mr. Morton cenolin. A vote was tatzon and the motion carried. It wae sucgosted by Mrs. Sohrartz that the comm1ttee on tho chartor try to consult with other communtios tho have done the same thing so as to bettor be able to drav up such a charter. It was sucgested that tho next meeting of the sroup be held one month from this mootIns date. It was moved that the meeting be adjoumed.
