APPLICATION FOR ARTICLES OF INCORPORATION

To the Honorable, the Judges of said Court.

In accordance with the Nonprofit Corporation Law of May 5, 1933, P.L. 289, your incorporators Eileen Wayne, Merton Canelin, Murray Alpern, Leonard H. Bortz, and Helford N. Bredie, present this application for incorporation of "BETH SHOLOM CONGREGATION OF BEAVER VALLEY", and represent as follows:

1. The name of the proposed Corporation shall be "BETH SHOLOM CONGREGATION OF BEAVER VALLEY", which name has been duly registered with the Department of State of the Commonwealth of Pennsylvania with six months before the date of this application. The Certificate of Registration by said Department is attached hereto.

2. The location and address of the initial registered office of the corporation in this Commonwealth is United Jewish Community Center, Chippewa Township, Beaver Falls, Pennsylvania.

3. The purposes of the proposed Corporation shall be the worship of Almighty God according to the faith of Israel as taught by Abraham and his descendants, Moses, the Hebrew Prophets and Sages; the learning and teaching of the said faith; and the exemplification of the principles of said faith through brotherly cooperation with fellowmen of all faiths in the alleviation of human suffering and promotion of human welfare and harmony.

The proposed corporation is a corporation which does not contemplate pecuniary gain or profit, incidental or otherwise, to its members.

4. The term of existence of the corporation shall be perpetual.
