The President, then called upon Mr. Maurice Chaitkin, pres. of the Cong. to act as toastmaster for the evening. The Toastmaster called upon the newly-elected officers to say a few remarks. The Secretary read the Financial report of the past year. It was moved and acconded to adopt the report as read. The motion was carried.

In the absence of the President, the Vice-president, Sam Middleman opened the meeting and presided. The roll-call of the officers was read; the absentees were Max Friedman, and Trustee Alex Glantz.

The minutes of the previous meeting were read and approved. The receipts and disbursements of the previous month were then read by the Secretary.

The Chairman of the Cemetery Improvement Committee A. Greenberger reported the concrete work was completed and was done very satisfactory, and recommended the payment of the bill which amounts, with all extra work to \$2401.60. He also reported that the bill for excavating, filling and grading amounted to \$579.98, the latter work not completed as yet, there being a few days work to be done. It was moved and seconded to accept the report of the chairman and approve the payment of the bills; the motion was carried.

The Secretary then presented the following Rules for adoption by the Chevra Kedisha, and if adopted, same to be presented to the Congregation for approval.

The resolutions were as follows:

1) That all graves in the new addition, if and when burials are arranged, to inform the parties concerne that the tombstones must be uniform stones, no beds, no rails, but flat graves with grass planted thereon.

20 That all present graves in the old Cemetery, if tombstones or beds or both are to erected, it shall be done throough the Congregation, supervised by a Committee of one or more members appointed by the Congregation for said purpose.

3) That all very old deserted graves having markers only, to flatten the graves; this we consider necessary in order to keep the cemetery in good clean condition. Moved and seconded to approve the the resolutions. The motion was carried. Being no further business, the meeting adjourned at 5:30 P. M.

September 4, 1938

The regular meeting of the Chevra Kedisha was held Sunday, September 4, 1938 at 4:30 P. M. at the Synagogue. The roll-call of the officers was read; the absentees were Trustees Jerome Edlis and Alex Glantz.

The minutes of the Previous meeting were read and approved. The receipts and disbursements of the previous month were then read by the Secretary.

The Chairman of the Cemetery Improvement Committee reported that the concrete work on the cemetery was complete, and the total cost thereof was \$2,401.60. The Total cost for labor for grading and levelling to date was \$579.98. However, he reported that there is some additional work which has to be done this coming week on account of the last two heavy rains, which casued considerable damage. The Chairman also reported that a water line all through the cemetery proper was installed, so as to enable us to water the ground when necessary. It was then moved and seconded to accept the report of the chairman and to discharge the committee with thanks.

Brother Greenberger then recommended to improve the Chapel with a tile floor in the lobby and main room, the cost thereof to be \$220.00. It was decided to defer action thereon for the present.

Brother A. Greenberger also recommended to appoint a Committee for the purpose of fixing prices for future reservations on the Cemetery.

There being no further business, the meeting adjourned at 5:30 P. M.

The minutes of the previous meeting were read and approved. The receipts and disbursements of the previous month were then read by the Secretary.

It was moved and seconded to hold a **Shebr**a Kedisha Sudah on Sunday, Feb. 26th, 1939 and to appropriate an amount not exceeding \$125.00 for same. The motion was carried. The President, Mr. J. C. Weinberger, appointed Adolph Greenberger, Chairman of the Sudah, with the power to appoint his own committees.

The Chairman, of the Cemetery Improvement Committee, Adolph Greenberger, then gave the final report of the improvement and the cost thereof. It was moved and seconded to accept the report of the chairman and discharge the Committee with thanks, The motion was carried.
