Charter of

Whereas we the under-
signed citizens of the Com-
monwealth of Pennsylvania

whose names are subscribed to this Charter or
certificate of incorporation have associated our-
selves together for the purpose and upon the
terms and by the name herein stated under
the provisions of an act of the General Assembly
of the Commonwealth of Pennsylvania entitled
an act to provide for the incorporation and
regulation of certain corporations approved the
twenty ninth day of April in the year of our
Lord one thousand eight hundred and seventy
four and the several supplements thereto, we
do therefore set forth and declare that,

1. The name of the corporation is the
"Base Avroham (the House of Abraham).

2. The purpose for which this Corporation
is formed are to exercise religious worship
according to the doctrines, discipline and uses
of the Hebrew Church.

3. The business of this corporation is to
be transacted in the City of Pittsburgh, Pennsylv-
ania.

4. The Corporation shall have perpetual
succession by its corporat. name.

5. There is no capital stock nor are there
any shares of stock. The names and residences
of the subscribers appear by their signatures here-
unto.

6. The number of the directors of the Cor-
poration is fixed at five and the names and
residences of those who are chosen directors
for the first year are as follows.

Moses Soubouff, Aaron Mozersky, Morris
Gelberg, Jacob Feldman, Henry Mozersky.

The corporation has no capital stock, fees for mem-
bership and annual dues from members will
be assessed as the corporation by its By. Laws
may determine which fees and dues will be
applied to promoting the purposes for which

the corporation is formed. Witness our hands

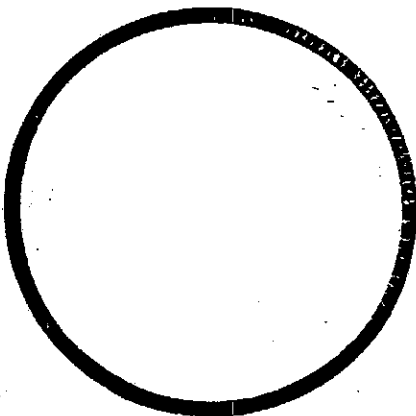
