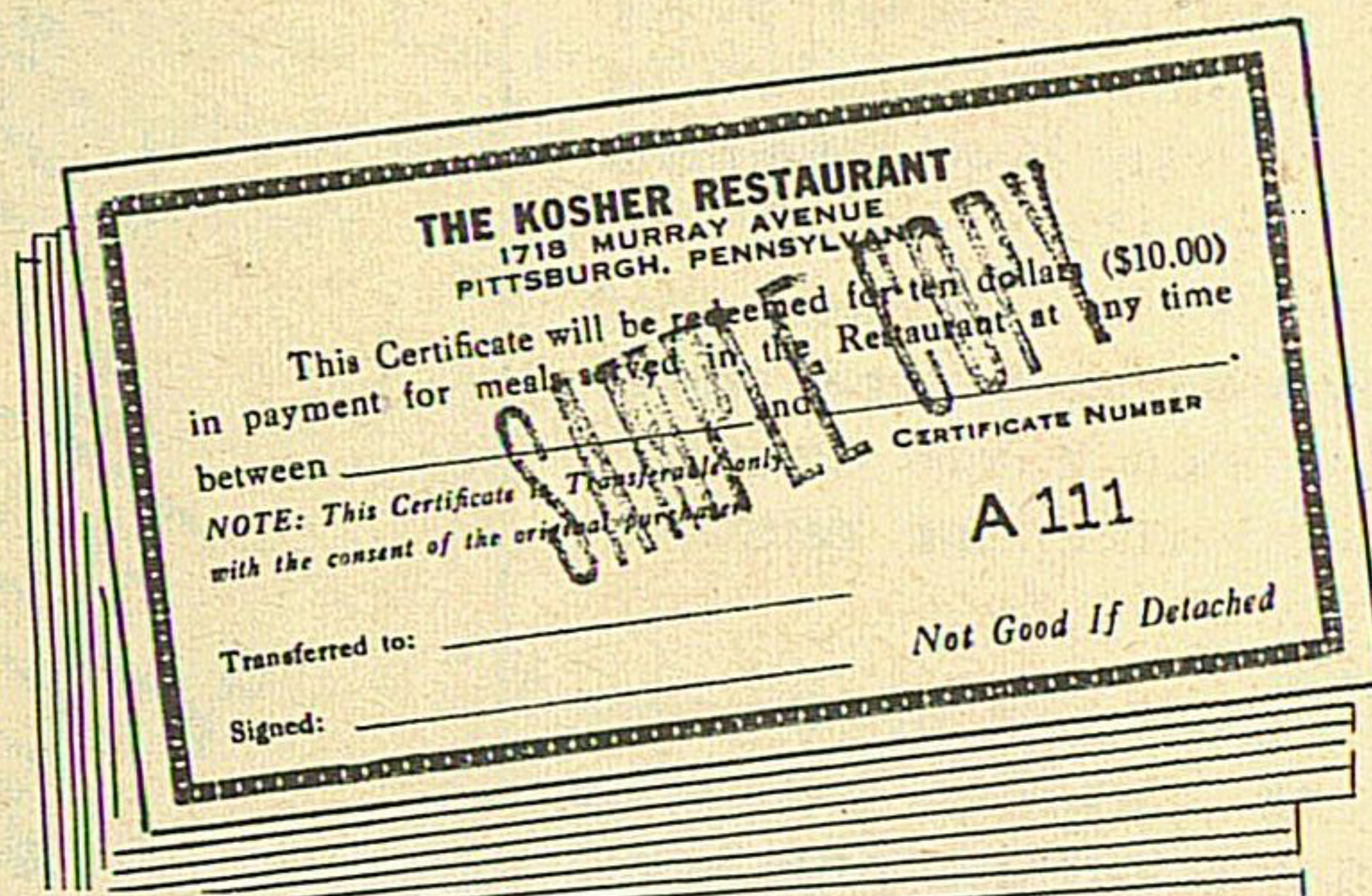
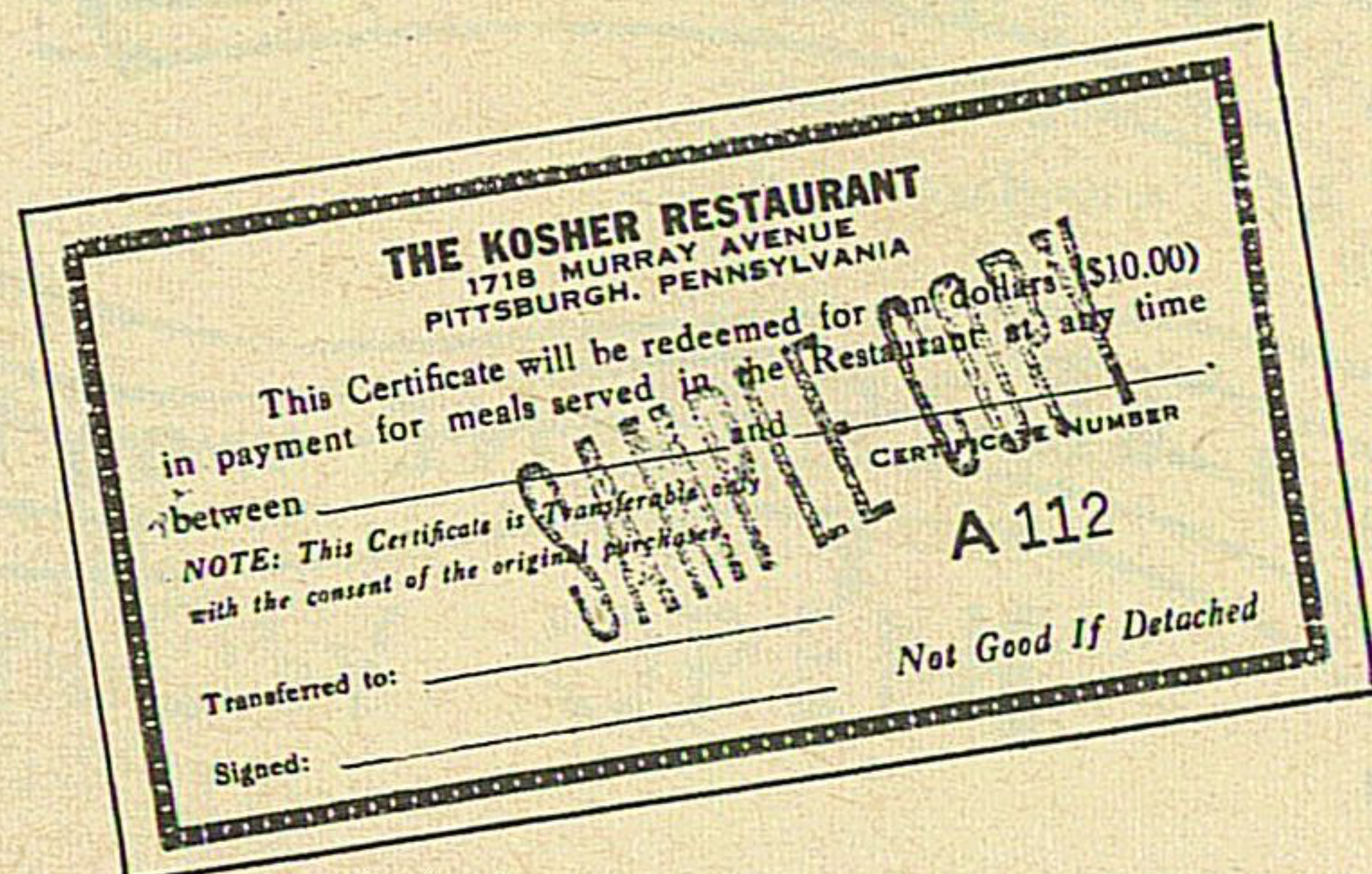

In order to establish the KOSHER RESTAURANT as a sound community enterprise, Sponsors Bonds are being sold to generate working capital that any new business requires.

This is the plan . . .

1. Sponsors Bonds valued at \$100, \$50, and \$25 are being issued for use beginning March 1, 1963.
2. The Sponsors Bonds will be redeemed for 10% of the face value of the Bond each month, immediately following the month of purchase. *For example*—a \$100 Bond bought in February of 1963 will be redeemed in the following manner: \$10 between March 1 and March 30; \$10.00 between April 1 and April 30, etc. as payments for meals in the Kosher Restaurant. This schedule of redemption of the Sponsors Bond is set up so that an orderly and immediate repayment will be made to purchasers of the Sponsors Bonds.
3. The Sponsors Bonds or Certificates from the Bond are transferable, with the consent of the original purchaser.
4. A Master File of all Bonds sold will be on hand at the Restaurant, protecting Bond owners against loss, etc.
5. Bond owners may leave their bonds on deposit in the Kosher Restaurant, to be available for use at any time.
6. Should the total check presented be less than the face amount of the specific certificate being redeemed, proper notation will be made on the reverse side of the Certificate, indicating the balance yet to be redeemed during the period specified.
7. Applications for the purchase of Sponsors Bonds should be accompanied by check or money order payable to "THE KOSHER RESTAURANT, Inc." for the full amount of the face value of the Bond. Upon receipt of application with payment, the Bond will be sent by Certified mail to the purchaser.
