D. 1874, and the several supplements thereto, having been incorporated by a decree of this Honorable Court at No. 39 June Term, 1907; and its Charter is recorded in the Recorder of Deeds Office of Allegheny County in Charter Book Volume 41, page 559. The purpos of said corporation is the "support of the public worship of Almighty God according to the faith, doctrine, discipline, and usage of the Orthodox Jewish Religion and for that purpose to maintain a synagogue." 2nd. That the CONGREGATION AHOVY SHOLEM LUBOVITSH OF PITTSBURGH is a corporation organizes and existing under the privisions of the Act of Assembly entitled "An Act to provde for the incorporation and regulation of certain corporations, approved the 29th day of Arril, A. The place where the business of the new or consolidated corporation is to be transacted is in the City of Pittsburgh, County of Allegheny, Commonwealth of Pennsylvania.
4. The management of the new or consolidated corporation shall be vested in a Board of Directors to be known as a Board of Trustees consisting of not less than three nor more than fifteen members, as provided for in the By-Laws. 5. The new or consolidated corporation shall have no capital stock. Fees for membership and annual dues of members shall be assessed as the new or consolidated corporation by its By-Laws shall determine, which fees and dues, as well as all other money or monies derived from all other sources, shall be applied to promoting the purpose for which the new or consolidated corporation is formed. . 6.
