) In the Matter of the Application for a Charter of Incorporation for the Roumanian Ladies Aid Society.  
To the Honorable the Judges of said Court:-  
In compliance with the requirements of the Act of the General Assembly of the Commonwealth of Pennsylvania entitled, "An Act to provide for the incorporation and regulation of certain corporations," approved April 29, 1874 and the supplements thereto, the undersigned at least three of whom are citizens of Pennsylvania having associated themselves together for the purposes hereinafter specified and desiring that they may be duly incorporated according to law do hereby certify:-

- 1 The name of the proposed corporation is "ROUMANIAN LADIES AID SOCIETY."
- 2 The purposes for which the said corporation is formed are the maintenance of a society for beneficial and protective purposes namely,- for the mutual relief of its members in case of sickness disability or death and to aid in the case of the deserving sick and indigent and the burial of the worthy poor and unfortunate among the Jewish people of Allegheny County; the corporation to be sustained by the payment of fixed sums as dues from its members and by voluntary contributions.
- 3 The business of said corporation is to be transacted in the City of Pittsburgh.
- 4 Said corporation is to exist perpetually.
- 5 The name of the subscribers are as follows:- Aneta Goldman, Sarah Weber, Bella Moscovitz, Jeannette Kupperberg, Rachel Hershcovitz, Sarah Panijel, Malka Horovitz Rachel Friedman, Sofie Birman, Lena Cohen, Pearl Malamet, Mollie Sperling, Goldie Bernstein Sarah Friedman, Bluma Marcus, Anna Braunstein, Ethel Rosenthal, Rachel Josephson, Marie Rosenthal, Anna Phinkel, Mollie Snyder, Rosa Choosat, Anna Benveniste, Elena Grunberg, Lena Wald, Lena Fox, Mollie Benjamin, Sophie Abramovitz Lena Kaufman and Lillie Silverman, all of whom reside in Pittsburgh, Pennsylvania.

- 7 Said corporation shall have no capital stock.
