Please take note of the following:

M., to pass on certain important amendments to the By-Laws, as recommended by the Board of Trustees, in accordance with the enclosed memorandum.

If the proposed change in the By-Laws is not adopted, the following names are submitted for re-election for a term of three years: Mr. Aaron Cohen, Mr. Maurice Falk, Mr. Irvin F. Lehman, Dr. Edward E. Mayer, Mr. A. L. Rauh, Mrs. Enoch Rauh, Mr. Max Rothschild, Mr. A. J. Sunstein.
