To the Honorable the Judges of the said Court:

In compliance with the requirements of an Act of the General Assembly of the Commonwealth of Pennsylvania, entitled "An Act to provide for the incorporation of certain corporations" approved the 29th day of April A.D. 1874, and the supplements thereto, the undersigned at least three of whom are citizens of Pennsylvania, having associated themselves together for the purpose of public worship, and desiring that they may be incorporated according to law, do hereby certify:

First: The name of the said corporation shall be "Beth Hamedrish Hagodal Congregation" of Pittsburgh.

Second: Said corporation is formed for the purpose of the support of public worship, according to the faith, doctrine, discipline and usages of the orthodox Jewish religion, and for that purpose to maintain a synagogue.

Third: The business of said corporation shall be transacted in the City of Pittsburgh, County of Allegheny and State of Pennsylvania.

Fourth: Said corporation shall exist perpetually.

Seventh: The yearly income of said corporation other than that derived from real estate shall not exceed the sum of Twenty Thousand (\$20000) Dollars.

Eighth: Any property real or personal which shall hereafter be bequeathed, devised or conveyed to said corporation shall be taken and held or given to it, subject to the control and disposition of the lay members thereof or such constituted officers or representatives thereof as shall be composed of a majority of lay members.
