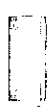

Frank Rubenstein of the Branna Construction Co. is to be contacted about the survey of the cemetery.

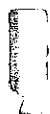
The President suggested that we have movies at our meeting.

And to write a letter of thanks to Mrs. Louis Weiner for the letter that she composed for the Memorial Day Service.

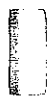
