

AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that

whereas the first PODOLIER INDEPENDENT SOCIETY of the City of Pittsburgh, County of Allegheny, State of Pennsylvania, formerly known as First Tomashpiler Independent Society, being a duly chartered corporation of the first class is the owner of a certain cemetery situated in the City of Pittsburgh, County of Allegheny, State of Pennsylvania, and in consideration of the payment of Two Hundred and no/100 (\$200.00)Dollars by the DAUGHTERS OF ISRAEL CEMETERY ASSOCIATION, a corporation of the first class, duly organized and chartered in the State of Pennsylvania, here-in referred to as the party of the second part, to the party of the first part, the said party of the first part hereby grants unto the party of the second part the right to use and occupy as a burial place a certain strip of ground situated in the cemetery owned by the party of the first part, said piece of ground being 16 feet in width by 100 feet in length and containing 25 burial lots, of which four burial lots have already been occupied and used by the party of the second part, said grant being subject to the following conditions:

(1) The party of the second party is to pay to the party of the first part the sum of Five and no/100 (\$5.00)Dollars before each burial lot is occupied, at or before the time it is occupied.

(2) Before a burial lot can be occupied by any member of DAUGHTERS OF ISRAEL CEMETERY ASSOCIATION, the party of the second part, that member's representatives or the party of the second part must guarantee to the satisfaction of the party of the first part that a suitable tombstone will be erected upon said burial lot within a reasonable time after the

body has been interred therein.

(3) The party of the first part is to keep the unused burial lots in good condition, that is the party of the first part agrees to maintain the unused burial lots just as it maintains the balance of the cemetery lots belonging to themselves.

(4) The party of the first part grants unto the party of the second part the right of way to and from the cemetery for the general uses provided for by a cemetery.

IN WITNESS WHEREOF, the said corporation the party of the first part has caused its common and corporate seal to be affixed to this instrument by the hand of its President and the same to be duly attested by its Secretary this 24 day of *March* A. D. 1932.
